

**SIGN IN AND RELEASE**

The undersigned agrees to use the facilities ( "facilities") and the real property located at 1805 Logue Road, Myakka City, Florida ( "Property") at his/her own risk. The Property and facilities are owned by Manatee County Gun and Archery Club, Inc. ("Club" or "Owner"). Some of the activities conducted upon the Property or at the facilities are conducted by third parties that have no legal affiliation with the Club other than as a licensee or lessee who are granted permission to conduct certain activities, such as training and other events, upon the Property or at a particular facility.

The undersigned acknowledges that the facilities and Property are used to operate firearms and archery shooting range(s) and related activities. The undersigned further acknowledges that the use of firearms and various archery equipment is a strenuous and potentially dangerous activity which may result in serious injury or death whether or not the undersigned participates in such activities. The undersigned voluntarily accepts the risk of all hazards of participating in or observing any activity conducted upon the Property, using the facilities, and those hazards that may exist in or upon the Property or at any facility whether known or unknown.

The undersigned unconditionally assumes any and all risks of damage or injury to himself/herself and others (including without limitation, personal injury, death and damage to property) relating to, caused by, arising out or on account of, or in any way connected with his/her participation in or observation of any activity upon the Property or at any of the facilities or his/her presence, conduct, or activities on, in, or about the Property. This assumption shall apply regardless of the fault or negligence of any person, including any employee, agent, officer, director, member or guest of the Club, any other participant, observer, or the Owner and any of its licensees, or lessees, and regardless of whether or not the damage or injury suffered is foreseeable or could have been prevented.

The undersigned unconditionally agrees that, regardless of the fault or negligence of any employee, agent, officer, director, member or guest of the Club, or the Owner or that of any of the Club's or Owner's licensees or lessees (excluding willful and unlawful misconduct), he/she will never make any claim or demand against the Club or Owner or any of their respective officers, directors, members, employees, licensees, or lessees for any injuries or damages to himself/herself or others (including without limitation, personal injury, death and damage to property) relating to, caused by, arising out or on account of, or in any way connected with his/her participation in any activity conducted upon the Property or his/her presence, conduct or activities on, in, or about the Property.

The undersigned further unconditionally forever releases and discharges the Club, any employee, agent, officer, director, member or guest of the Club, the Owner and any of the Club's or Owner's licensees or lessees (excluding willful and unlawful misconduct) and their successors and assigns from and with respect to all damages, losses, claims, demands, costs, expenses, suits, obligations, causes of action, orders, judgments and liabilities of whatever kind or nature, in law, equity, or otherwise, which the undersigned can, shall, or may have for, upon or by reason of any matter, cause or thing whatsoever relating to, caused by, arising out or on account of, or in any way connected with the fault or negligence of any employee, officer, director, member or guest, licensee, or lessee of the Club or Owner relating to, caused by, arising out or on account of, or in any way connected with his/her participation in any activity conducted upon the Property or at any facility, or his/her presence, conduct or activities on, in, or about the Property.

The undersigned acknowledges that he/she is aware of, knows, and will comply with all rules for the safe handling of firearms and archery equipment and represents that any firearm or archery equipment used by the undersigned upon the Property is in good working order. The Club promulgates and enforces other or additional rules and safety guidelines designed to promote the safety and welfare of all participants and persons using or who may be upon the Property. The undersigned agrees to follow all safety rules and obey all commands of any range or other safety officer ("RSO") while on the Property, using any facility, or participating in any activity upon the Property. Failure to observe and comply with any safety rule or measure may subject the undersigned to being ejected from the Property. Notwithstanding and despite its best efforts, the Club cannot and shall be deemed to insure the undersigned against any injury or damages (including without limitation, personal injury, death and damage to property).
