My involvement with MGAC started as a non-member, and after the first day shooting, my wife (Sydney) and I signed up to be members before leaving the range. As members, we shot the mainline only, providing assistance to other shooters when needed. The SCRSO, Billy Tutko suggested that we should become RSOs for MGAC, which we did. We committed to volunteering 1 day a week as RSOs. We did that for over 3 years, when I was asked to fill the opening for an interim director in December of 2020 to run to March 2021.

During that time, I have been proactive as a director in supporting the officer and directors in any decisions, insuring what is best for MGAC.

In February 2021, Syd and I were asked if we could setup a pistol multi position and multi target course of fire for MGAC shooters. We were asked because of our extensive knowledge in: self defense and tactical shooting, proficiency with handguns and rifles, and our ability to interact with the shooters. Hence, the PCC committee was formed. I asked if we could have Rickey Ruebsamen to also be part of that committee, due to his equal knowledge, experience and inter-personal skills.

Between February and March 2021, we setup the pistol course of fire. We then did extensive testing with select shooters. By March of 2021, I submitted to MGAC board the Pistol PCC SOP), and it was approved. We started charging in May 2021 for shooters at Pistol PCC. Concurrently in March 2021, using the same target array, but from different distances, we began testing the Pistol Caliber Carbine course of fire using selected shooters. I submitted the Pistol Caliber Carbine course of fire in May 2021, which the board approved, providing MGAC with additional revenue. The next course of fire to follow was the Pistol Caliber Carbine to Pistol (tested for 5+ months). The updated PCC SOP was submitted to the board in December

2021 and passed. This additional course of fire provides a third source of revenue, utilizing a composite of the same targets and shooting positions.

All of the above was accomplished with minimal cost to MGAC. We commandeered almost all of what we needed from the range, to set up the respective courses of fire. We even used an old 10' x 10' pop-up tent through December 2021.

My focus as a MGAC director in setting up the PCC, was to insure that it would be self-sustaining. That is the revenue generated by the PCC would cover all of its expenses and still make MGAC a profit. To date, the PCC continues to meet that goal. It will never, nor was it ever, intended to bring in the revenue that the Mainline brings in for MGAC. However, it has created another reason for shooters to come to the range. Currently, the PCC is running a split of 50% members and 50% non members. Everything is tracked, with a monthly report to the Officers and Directors. All of the PCC procedures and forms used for the PCC operations have been documented. The PCC Best Shot Competition is fully documented, including how the RSOs will run the competition. Now that we are on Microsoft 365, I will be moving these files to the MGAC's Cloud files.

Syd and I staff the PCC 3 days a week, yet I still find time to perform all of my duties as a director. As a Re-elected Director and a continued member of the Strategic Planning Committee, I hope to be equally productive in supporting MGAC in all of its future goals, with the same focus as the PCC.
